STUDENT AGREEMENT

Contract agreement between MY Learning Center Facility and Parent of Child Attending MY Learning Program

Supplies

- The student must adhere to the proper use of supplies provided by the Center.
- Students are not allowed to break, misuse, or treat pencils, crayons, or markers as toys within the Center premises.

Car Etiquette:

- Center vehicles are equipped with dashboard cameras to record inside and outside the vehicle.
- All students must conduct themselves in a well-behaved manner during transportation.
- No climbing over the seats, eating, or drinking in the vehicle.
- Windows and doors will remain locked during the ride for the safety of all students.
- Screaming or fighting will not be tolerated for the safety of the driver and other students.

Packet Responsibility:

- Students will be provided with extra packets, and all students will be assigned folders.
- It is the responsibility of the student to maintain a clean folder and treat it with respect.
- Scribbling on folders will not be tolerated, and a \$5 charge will be applied to the parents' account.
- Parents must notify the Center if they do not want their child to participate in the packet activities.

Conduct in the Center:

- Students must conduct themselves in a proper manner within the Center.
- Running or skipping is not allowed within the Center premises.
- Students must keep their voices low to allow other students to concentrate on their work.
- Challenging the tutor or using inappropriate language will result in dismissal from the program.

Computer Responsibilities:

- Students are only allowed to use a Chromebook with the permission of the tutors.
- It is recommended for students to bring their own headset to minimize sound disturbance for other students.
- Chromebooks must be returned to the computer cart for charging.
